

Postgraduate Student Term Time Guide (Academic year 2024 – 2025)

There are no official recognised vacation periods for postgraduate September and January starters within the academic calendar at St Mary's University.

Postgraduate students can work up to 20 hours weekly in part-time jobs from the start of their course to the submission of the dissertation or final piece of work, with no pending resit.

This means that they are NOT permitted to work more than 20 hours weekly at any time between the first date of their course to the submission of the dissertation or final piece of work.

For the purpose of this guide, postgraduate courses refer to Master of Science, Master of Arts, PGCE courses. Mphil, MRes, PhD courses are NOT included here.

The term dates below apply to most postgraduate students. However, the time between each term generally indicates that there is little or no teaching and class attendance. This should not be regarded as a break of academic engagement for postgraduate students who must be continuously committed to the studies and research of an intense 12-month Level 7 programme. Writing-up of a dissertation is also deemed as term-time.

Autumn Term	Monday 2nd September - Sunday 8th December 2024
Spring Term	Friday 3rd January - Friday 28th March 2025
Summer Term	Monday 7th April - Friday 27th June 2025

Eligible periods for full-time non-permanent work or part-time work exceeding 20 hours weekly:

From the submission of the dissertation with no resit until the Student visa's expiry date

A Student visa holder must not undertake full-time work which fulfils a permanent vacancy. A contract for any full-time work during the permitted period above must end before the student visa's expiry date. If part-time jobs are taken, the term for these contracts can be ongoing.
